Consequent upon the receipt of indent/requisition from the Social Welfare Department, vide Indent No. vide Indent No. SWD-ESTB/53/2021-01 dated: 23.03.2023 and SWD-ESTB/53/2021-01 dated 25.05.2023, forwarded the requisition for making direct recruitment to the 201 posts of "Supervisor" under various Item nos. The Jammu and Kashmir Services Selection Board (JKSSB) advertised the 201 posts of Social Welfare Department vide Advertisement Notification No. 02 of 2023 dated 08.12.2023.

The Social Welfare Department conveyed change in the available posts in respect of various categories/cadres already advertised and against 201 posts so advertised, the department revised the number of posts to **186**. The category/cadre-wise details of the posts are

As per the Indent, the qualification prescribed for the posts is as follows:

## "Female Graduate. Preference shall be given to candidates having Home Science, Child Development/ Sociology as one of subject."

The Document Verification of candidates falling under the consideration zone was conducted vide Notice No. JKSSB/COE/1/2024-06 (748053) dated: 05-10-2024 both at Jammu and Srinagar Offices of JKSSB by the DV Committees constituted vide Order No. 345-SSB of 2024 dated 07.10.2024. Separate DV committees for the candidates who failed to appear for DV on the scheduled date and time was also constituted vide Order No. 360-SSB of 2024 dated 24.10.2024.

The Selection Committee for preparing the Selection to the aforementioned posts was constituted vide Order No. 372-SSB of 2024 dated 05.11.2024, which was superseded by a reconstituted selection committee vide order No. 427-SSB of 2024 dated: 24.12.2024; and

The Final Selection List for the above mentioned posts, was approved by the Board in its 298<sup>th</sup> Board Meeting held on 24.02.2025 and the recommendations were forwarded to the Indenting Department vide communication dated 24.02.2025; and

In the said forwarded list 01 slot was kept reserved under Item No. 09, District Cadre Jammu in OM category on the directions of Hon'ble Central Administrative Tribunal, Jammu vide judgment dated 23.12.2024 in the **O.A No. 61/1330/2024 titled Nancy Sharma Vs UT of J&K and Others** (operative part as under):

"...Till filing of reply, one post of Supervisor in terms of Advertisement Notice No. 02 of 2023 dated 08.12.2023 in the Social Welfare Department, District Cadre Jammu shall be kept reserved."

The matter was contested before the Hon'ble Tribunal and the Hon'ble CAT, Jammu vide judgment dated 06.03.2025 disposed off the case with the following directions (operative part as under):

"... 18. In light of the discussions made above and in view of the order/judgment passed by Co-ordinate Bench of this Tribunal in T.A. No. 6159 of 2021 and T.A. No. 6160 of 2021, in identical set of facts, we are inclined to take the same view and hold that 05 additional marks for possessing post graduation in Home Science course cannot be granted to the applicant for the post of Supervisor advertised in terms of Notification No. 02 of 2023 dated 08.12.2023.

19. Accordingly, this O.A. is dismissed and the interim directions dated 23.12.2024 for reserving one post of Supervisor in terms of aforesaid advertisement in Social Welfare Department, District Cadre Jammu stands vacated.

## 20. No order as to costs."

In compliance to the directions passed by the Hon'ble Tribunal the matter was considered by the Board (Agenda through circulation on 12.03.2025) and it was decided to fill up the post of "Supervisor, Social Welfare Department" advertised vide Advertisement Notification No.02 of 2023 dated 08.12.2023, under Item No. 09 (District Cadre, Jammu) under OM category with the candidature of the candidate who was already figuring at S.No. 05 in the Provisional Selection List under Selection Category OM/RBA.

Accordingly, the undersigned is directed to forward herewith the filled-up slot in the Final Selection List for the aforementioned posts of Supervisor, Social Welfare Department, advertised vide Advertisement Notification No.02 of 2023 dated 08.12.2023, under Item No. 09 (District Cadre, Jammu) under OM as **Annexure- "A"** to this communication, which has been notified vide Notification No 02-Selection of 2025 dated 24.02.2025 issued under endorsement No. JKSSB-Scry/5/2025-03 (E- 7642007) dated 24.02.2025.

The above Selection shall be subject to the outcome of writ petition(s), if any, pending disposal before any competent Court of jurisdiction related to the selection. The Selection shall also be subjected to the outcome of any inquiry, involving candidate(s), figuring in this Selection List.

The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/Degree Certificates. While ascertaining genuineness/validity etc. or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/Appointing authority.
